



- Project** : Comprehensive review of the Strategic Trade Act 2010 (STA 2010) and its subsidiary legislations.
- Progress** : 35 Amendments, 6 New Provisions (ITT, Expert Witness etc) based on international best practices and latest development in Strategic Trade Management.
- FGSTAR Meeting** : Conducted at least four times/month to ensure timely progress and alignment with the objectives.
- Effective date:** : 1 January 2026 (tentative).


- Project** : Review and updating the SIL

- Effective date** : Q4 2024 (tentative)




