1. Who is National Council of Social Service (NCSS)?

The National Council of Social Service (NCSS) is a statutory board under the Ministry of Social and Family Development. As Singapore's sector developer for social services, NCSS works with partners to strengthen the social service ecosystem and support a caring and inclusive society.

Through our research, platforms, enabling resources and engagements, we aim to identify gaps and areas needing support, invest in developing key capabilities within the sector and rally community and corporates to support crucial causes in the social service sector. In doing so, we hope to develop a sustainable and connected ecosystem for a caring and inclusive society.

Research & Insights

13. What type of research does NCSS carry out?

NCSS conducts various nationwide surveys in a bid to produce research findings that guide our organisation, social service agencies, funders and other stakeholders in developing and prioritising evidence-informed solutions to improve the lives of different population segments in Singapore.

Using a variety of methodology (e.g., longitudinal/ panel and birth cohort studies; environmental scanning and sense making; economic evaluation), NCSS examines various areas of research, including family and child welfare, offending and rehabilitation, population studies, social service provision, and quality of life.

14. How can I sign up to be a research volunteer?

Interested to make use of your research or data analysis skills and expertise for a good cause? Register as a [volunteer researcher](#).

Volunteer researchers can expect to provide advice or direct support to social service agencies in the following areas: study design and methodology, crafting of questionnaires or discussion/interview guides, and quantitative or qualitative data analysis. All projects will begin with a six-month commitment period as default.

Volunteer researchers can negotiate with social service agencies on mutually agreed parameters of the consultancy e.g., scope of assistance, level of commitment, frequency of meetings, expected project duration, data sharing, intellectual property, and publication etc.

15. I received an invitation to participate in an NCSS study. What should I do?

NCSS conducts regular surveys to understand the well-being of various population groups to inform policy formulation and service planning.

NCSS-commissioned fieldwork vendors engage in door-to-door knocking to ask participants if they are interested in participating in our surveys. They may leave a note at your door stating the time and date they came and include a number to call if you are interested in participating in the survey.

If you are interested in participating in the survey, please call the number stated to schedule another time slot. If you are not interested in participating in the survey, you can also call the number to remove your address from the contact list for this survey.

If you want to confirm the legitimacy of the survey, please email research@ncss.gov.sg for assistance and indicate the survey title you have been invited to join.

19. What are the internship opportunities in NCSS?

NCSS works with several local Institutes of Higher Learnings (IHLs) to provide internship opportunities. If you are attending a local IHL, do check your school's internship job portal for internship opportunities at NCSS.

20. How do I apply for a scholarship?

If you are an in-sector professional intending to further your studies, we encourage you to discuss your career and personal development plans with your employer. There are available schemes, such as the PCG VCF Training Grant, the Professional Development and Management Programme (PDMP) and Leadership Development Programme (LDP) that you can apply for to pursue full-time and part-time studies.

We do not encourage in-sector professionals to terminate their employment in order to be eligible for the NCSS Social Service Scholarship, as this is targeted at new entrants.

21. What courses are supported by the NCSS Social Service Scholarship?

The NCSS Social Service Scholarship supports full-time undergraduate and postgraduate studies from local and overseas universities, recognised by professional accreditation bodies in the following areas:

- Social Work
- Psychology (Postgraduate only)
- Occupational Therapy
- Physiotherapy
- Speech Therapy

Please note that the course of study and universities must be recognised by the relevant professional accreditation bodies.

24. How do I get information on a social service agency?

You can ensure that a social service agency is legitimate if it has a formal registration with a legal authorisation body that incorporates its status as a charitable organisation. Some of these bodies include the Registry of Societies, the Registry of Companies and the Commissioner of Charities.

You can also approach National Council of Social Service (NCSS), the coordinating body for social service agencies in Singapore, for an informed opinion of its member organisations.
