New NCSS Council Takes Office as Amended NCSS Act Takes Effect

1. The Ministry of Social and Family Development (MSF) today announced the appointment of the governing body (known as the Council) of the National Council of Social Service (NCSS) for a three-year term from 1 August 2026 to 31 July 2029. The new Council takes office as the amended NCSS Act comes into effect, marking a significant milestone in strengthening NCSS' role as the social service Sector Developer. In this expanded role, NCSS will work in close partnership with Social Purpose Entities – social service agencies (SSAs), community partners and other stakeholders – to strengthen services, build sector capabilities and drive better outcomes for individuals and families in need.

Key Appointments to the New Council

2. Mr Gregory Vijayendran has been appointed Chairman of the Council succeeding Ms Anita Fam, as earlier announced in June 2026. Ms Ong Toon Hui has been appointed as the Deputy Chairman of the Council and Mr Danny Koh has been appointed as the Chairman of the Community Chest.

3. The incoming Council consists of 21 members, appointed by the Minister for Social and Family Development, Mr Masagos Zulkifli. Eleven have been appointed from among the candidates nominated by NCSS member organisations. A Sector Nominations Committee, chaired by then-NCSS President Ms Anita Fam and comprising individuals with deep sector experience and expertise, had been appointed

to assess the sector nominees and recommend suitable candidates to the Minister. The full list of Council members is in Annex A.

Strengthening the Social Service Sector

4. In the coming term, the Council will guide NCSS' priorities as Sector Developer at a time when social needs are becoming more complex and SSAs face increasing demands to meet the needs of service users. A key priority will be the review of the roadmap for the social service sector for the next decade. As part of this effort, NCSS will engage with the sector to build shared ownership of the future directions for social services and co-create the shifts needed to foster a more effective, future-ready and sustainable social services sector in Singapore.

5. "Social needs are becoming more complex, multifaceted, and interconnected. As Sector Developer for the social service, NCSS works closely with partners across the ecosystem to strengthen capabilities, shape effective services and standards, foster sustainable philanthropy, and improve service delivery. Our overall aim is to improve the quality of life of those we serve. I look forward to working closely with the sector as we continue in our shared journey together," said Mr Gregory Vijayendran, Chairman, NCSS.

6. MSF expresses its appreciation to Ms Anita Fam and all outgoing Board Members for their service to NCSS and the social service sector. Their dedication has been instrumental in supporting the sector to uplift those in need.

Profiles of NCSS Council Members

Mr Gregory Vijayendran

Chairman

Mr Gregory Vijayendran is a partner at Rajah & Tann Singapore LLP, specialising in dispute resolution. He served as the founding Chairman of Pro Bono SG from 2017 to January 2025, the access-to-justice arm of the Law Society, and thereafter, completed his term as a Board Member of Pro Bono SG in end July 2026. Gregory was the inaugural Pro Bono Ambassador of the Law Society in 2009 and has actively served in community-based legal clinics and represented indigent clients. He also specialises in charities governance and currently serves on the Charity Council.

Gregory has a longstanding involvement in community service, having served as Vice President of the Children's Cancer Foundation from 1992 to 1995, chaired Camp Rainbow from 1994 to 1995, and served as President of Club Rainbow (Singapore) from 1996 to 2015. He is currently Chair of the Bioethics Advisory Committee, a Board Director of the Agency for Integrated Care and a Member of the Council for Board Diversity. He is also serving as a Trustee of the National Youth Fund and served as President of the Tribunal for the Maintenance of Parents from 2022 to 2025 after serving as Member and Deputy President from 2015.

Ms Ong Toon Hui

Deputy Chairman

Ms Ong Toon Hui is the current President of the Board of Management of SPD Ltd, a charity that serves people with disabilities. Since joining SPD in 2016, she has held various board roles, including Chairperson of the Human Resource and Remuneration Committee and Vice President. During her tenure, she has guided the organisation through significant growth in both staff strength and range of services.

In her professional career, Toon Hui is the Vice Dean and Executive Director of the Institute for Governance and Leadership at the Lee Kuan Yew School of Public Policy, National University of Singapore. Before this role, she served for 30 years in the Singapore's Public Service, including as Dean and CEO of Singapore's Civil Service College and concurrently Deputy Secretary (Leadership) in the Public Service Division. She has served in various capacities throughout her public sector career in the Ministry of Health, Ministry of Education, Public Service Division, and the Ministry of Social and Family Development.

Her public sector experience includes overseeing leadership development and human resource policies in the public service, policies on social safety nets, family development, social sector development, and protection of vulnerable segments of society. In recognition of her contributions, Toon Hui was awarded the Public Administration Medal (Gold) in August 2021.

Mr Koh Thong Meng, Danny

Community Chest Chairman

Mr Danny Koh is the founder and Chief Executive Officer of Tower Capital Asia, with over 20 years of private equity experience in the investment industry. He was appointed Vice-Chairman of Community Chest in 2022, and has served on NCSS' Investment, Audit, and Services Committees since 2008. From 2010 to 2019, he was also a Board Member of Singapore Association for Mental Health, a member of NCSS.

Throughout Danny's time in Tower Capital Asia, he has championed corporate philanthropy, encouraging both companies and individuals to contribute to charitable causes while fostering partnerships that create lasting impact. In recognition of its contributions to the community, Tower Capital Asia received the Community Chest Platinum awards in 2016, 2025 and 2026.

He also serves on the Board of Vanguard Healthcare and on the Panel of Experts at AWWA, contributing to the design of integrated care models. His work reflects a strong commitment to advancing social-health integration, strengthening care coordination and addressing service gaps to improve outcomes for individuals with complex needs.

Ms Shahrany Binte Hassan

Ms Shahrany Hassan is the Chairperson of Casa Raudha, a crisis shelter for victims and survivors of domestic violence. Currently serving her second term, she continues to lead the organisation in supporting its three thrusts; Protection (providing shelter), Prevention (education and engagement) and Restoration (providing support and resources).

Shahrany is also the founder of The Whitehatters, a non-profit organisation that advocates building a socially cohesive society that transcends religious, racial and social barriers. Her work has earned mentions in Parliament and has been featured numerous times in the media.

At the height of the COVID-19 pandemic, Casa Raudha together with The Whitehatters, led a successful campaign against domestic violence that reached over a million people online, creating awareness of this important issue through various media, such as interviews, podcasts, and op-eds.

Dr Julian Hong is a physician-executive and Director, Clinical Governance and Medical Affairs at Foundation Healthcare Holdings. He leads clinical governance, patient safety, and care standardisation across a multi-site network of clinics and ambulatory centres. Separately, Julian works across primary care and population health, contributing to community-level healthcare coordination and the integration of health

and social services for vulnerable populations. He is an NCSS 40-Under-40 alumnus and Singapore National Cooperative Federation Emerging Leader.

Under Karthik's leadership, AWWA has received the Charity Transparency Award four times, the Excellence in Learning & Development, Coaching & Mentoring (Gold) prize at the Singapore Human Resources Awards 2025, and its first SkillsFuture Singapore Employer Award (Gold) as the sole social service agency recognised in 2024.

For his leadership, collaborative spirit, and commitment to strengthening inclusion in society, Karthik was awarded the President's Award 2025, the highest accolade for social service professionals. Passionate about harnessing the value of high-quality partnerships, he is an accomplished Social Service Fellow, and he sits on the Board of the TTSH Community Fund. Karthik is also a member of the Allied Health Professions Council (appointed by the Ministry of Health), and a faculty member of the Centre for Healthcare Innovation (NHG Health).

From 2007 to 2025, Chee Foong served SHINE Children and Youth across multiple committees including Service Advisory, Staff & Services, Finance, and Fundraising. He later served as Chairman of the SHINE Board from August 2019 to August 2025. During his tenure, he was instrumental in driving strategic transformation, championing digitalisation, and deepening competencies. Additionally, Chee Foong has been an active grassroots leader since 2013 and served on the Institutional Review Board of SUSS. Over the last 35 years, he has dedicated himself to volunteering, with a focus on maximising the potential of vulnerable children and youth.

Ms Wee Judy Anne

Ms Judy Wee is Executive Director of the Muscular Dystrophy Association (Singapore) (MDAS), where she leads programme development, partnerships and service delivery for persons with neuromuscular conditions. She brings extensive experience across the corporate and social service sectors, having transitioned to full-time work in the social service sector in 2007. Her expertise spans disability services, organisational leadership and stakeholder engagement, underpinned by a strong focus on advancing inclusive policies and practices.

Judy has contributed to the sector through leadership roles with HWA (formerly known as the Handicaps Welfare Association) and the Disabled People's Association.
