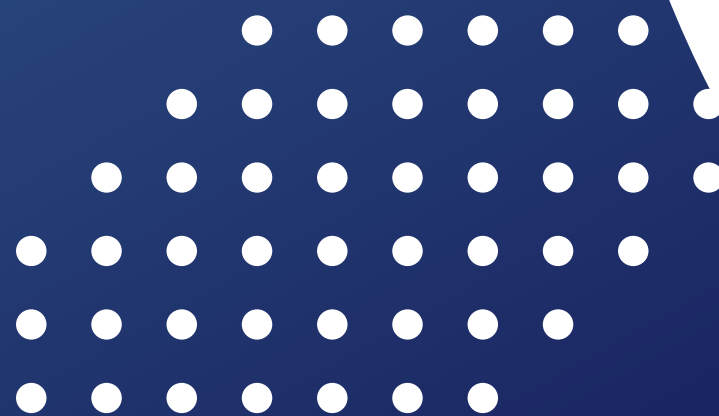

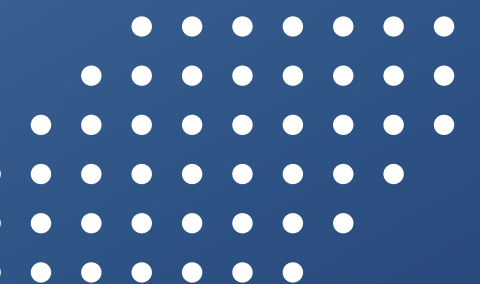

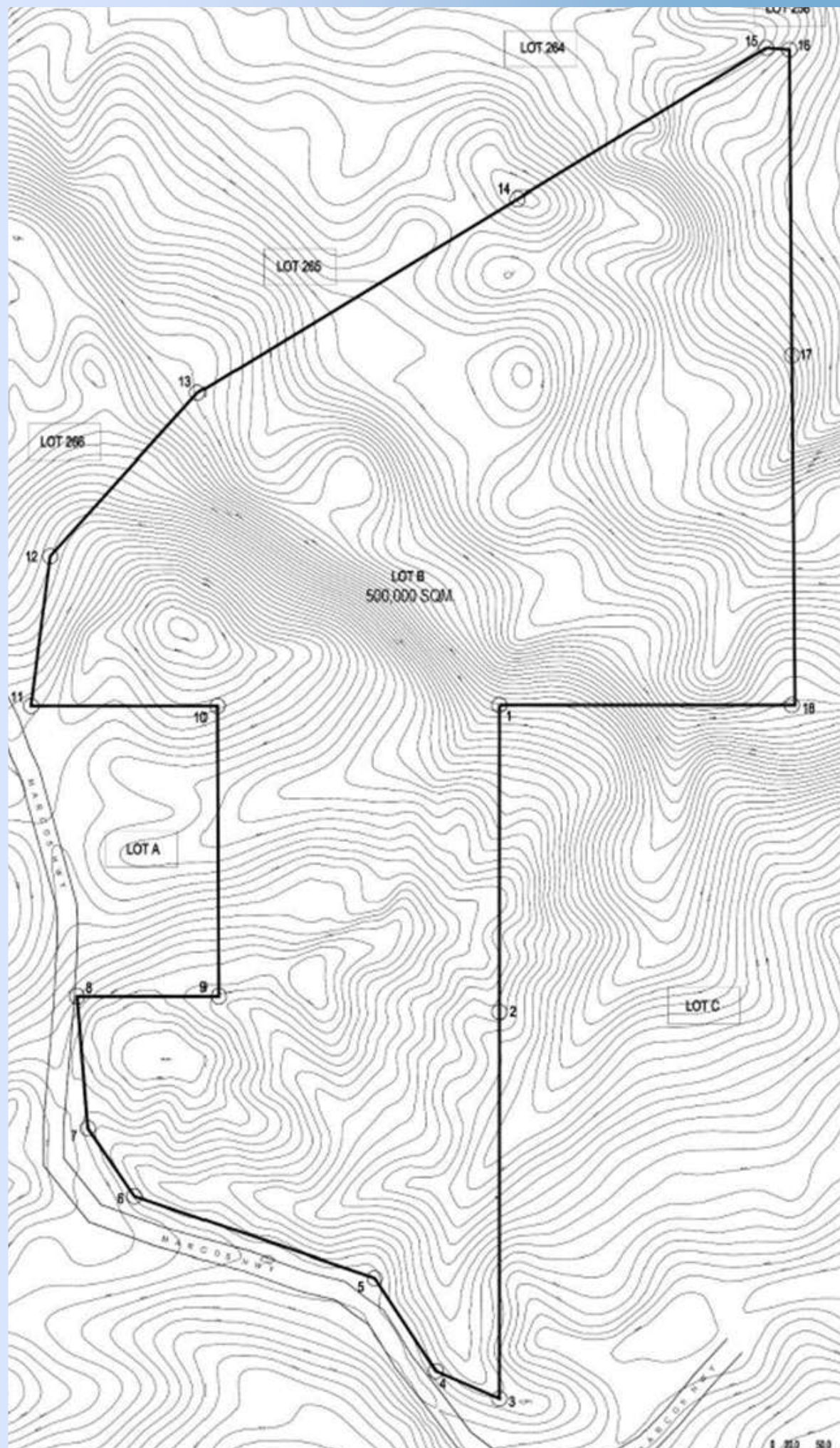


LEGAL BASIS



Through the Letter of Instructions (LOI) No. 856, s. 1979, the ECC was mandated to establish and operate a Workers' Rehabilitation Center Complex (WRCC) that would offer comprehensive disability management and rehabilitation services for persons with work-related disabilities (PWRDs) in both the public and private sectors.

This certificate is a transfer from Original Certificate of Title No. 456/1-I-2, which is cancelled by virtue hereof in so far as the above described land is concerned.

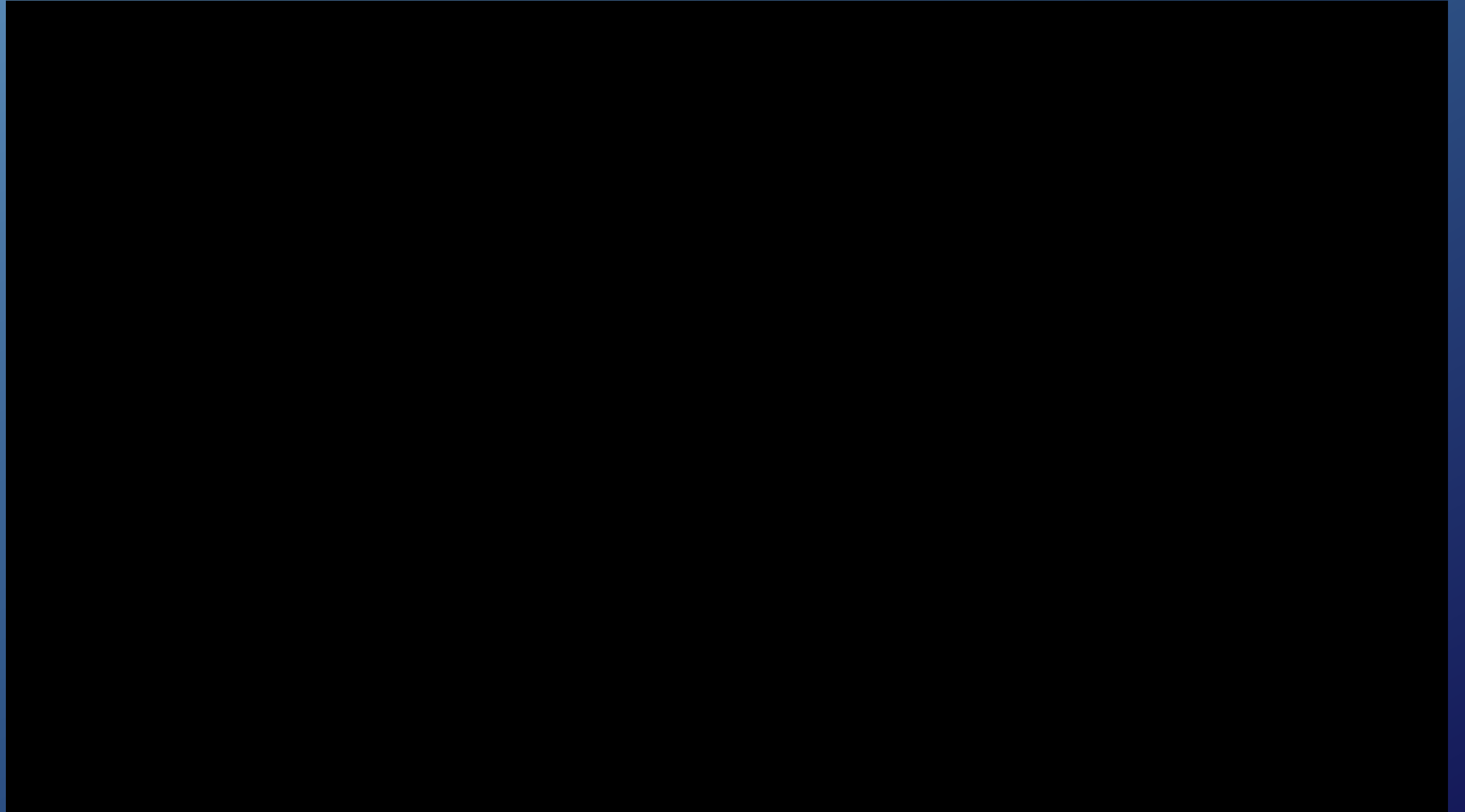

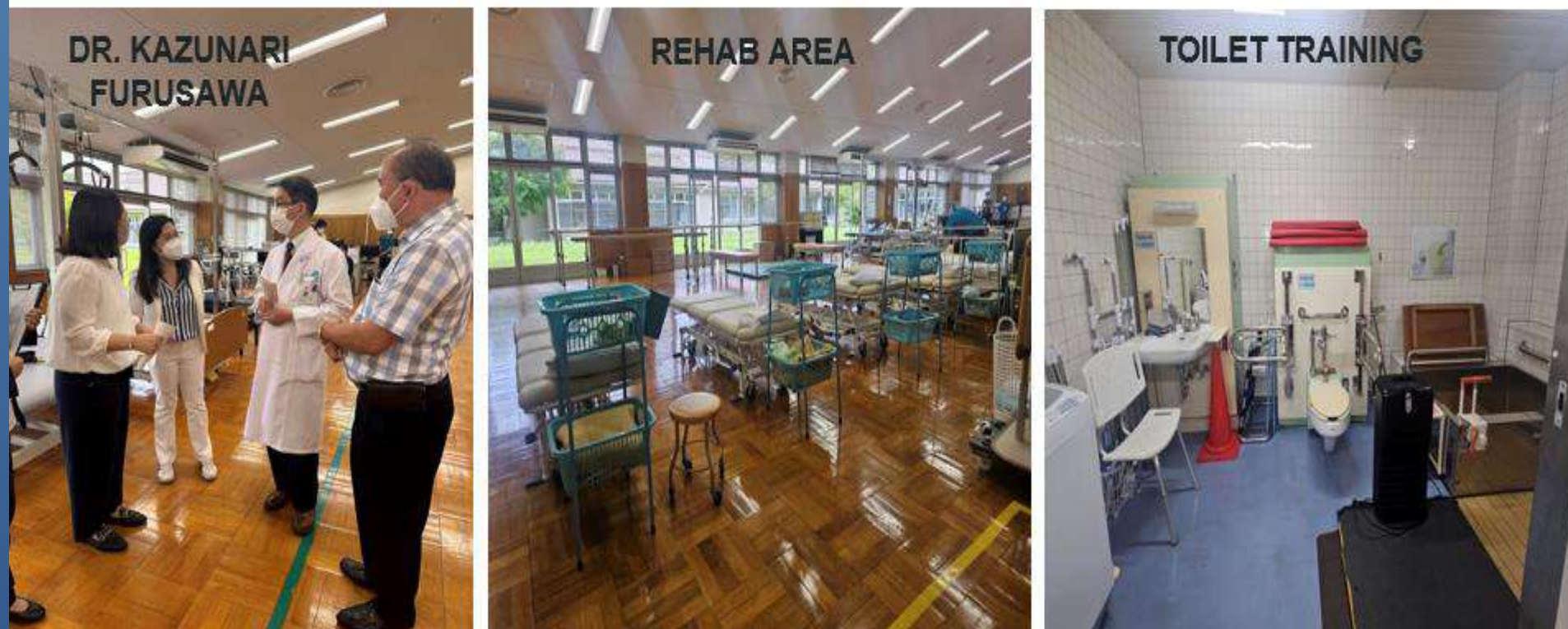

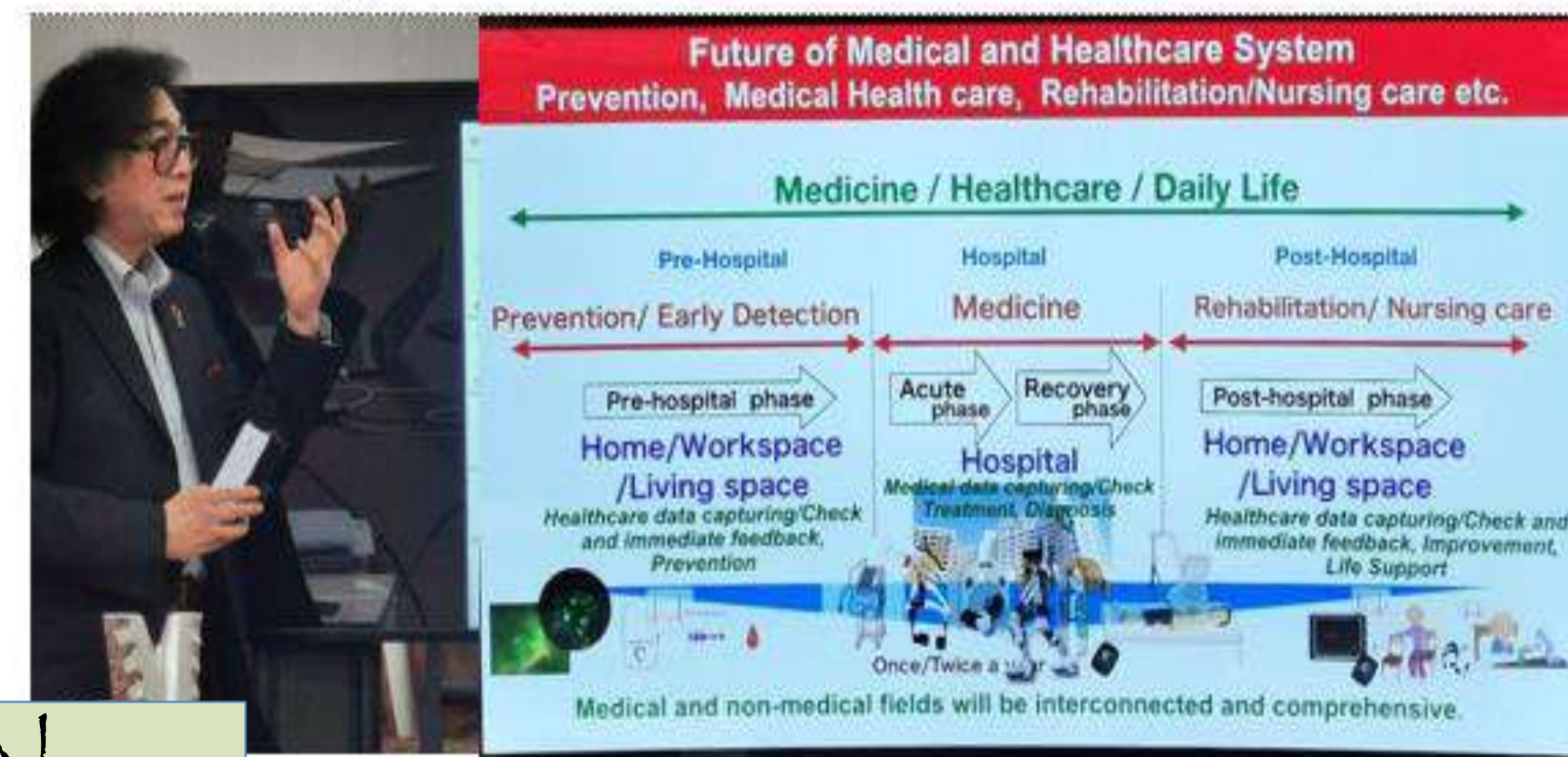

The WRCC is a key facility for the implementation of the ECC DM-RTWAP that ensures that our workers receive the support they need to return to work by:

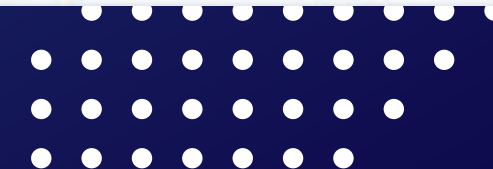
- Provide rehabilitation services that address the diverse needs of workers. This may include specialized therapies for gender-specific injuries or illnesses.
- Offer counseling and support services that address the psychological and emotional impact of work-related injuries, taking into account potential gender differences in coping mechanisms.
- Vocational training programs that are not gender biased, and that allow both men and women to have equal opportunities to gain new skills.

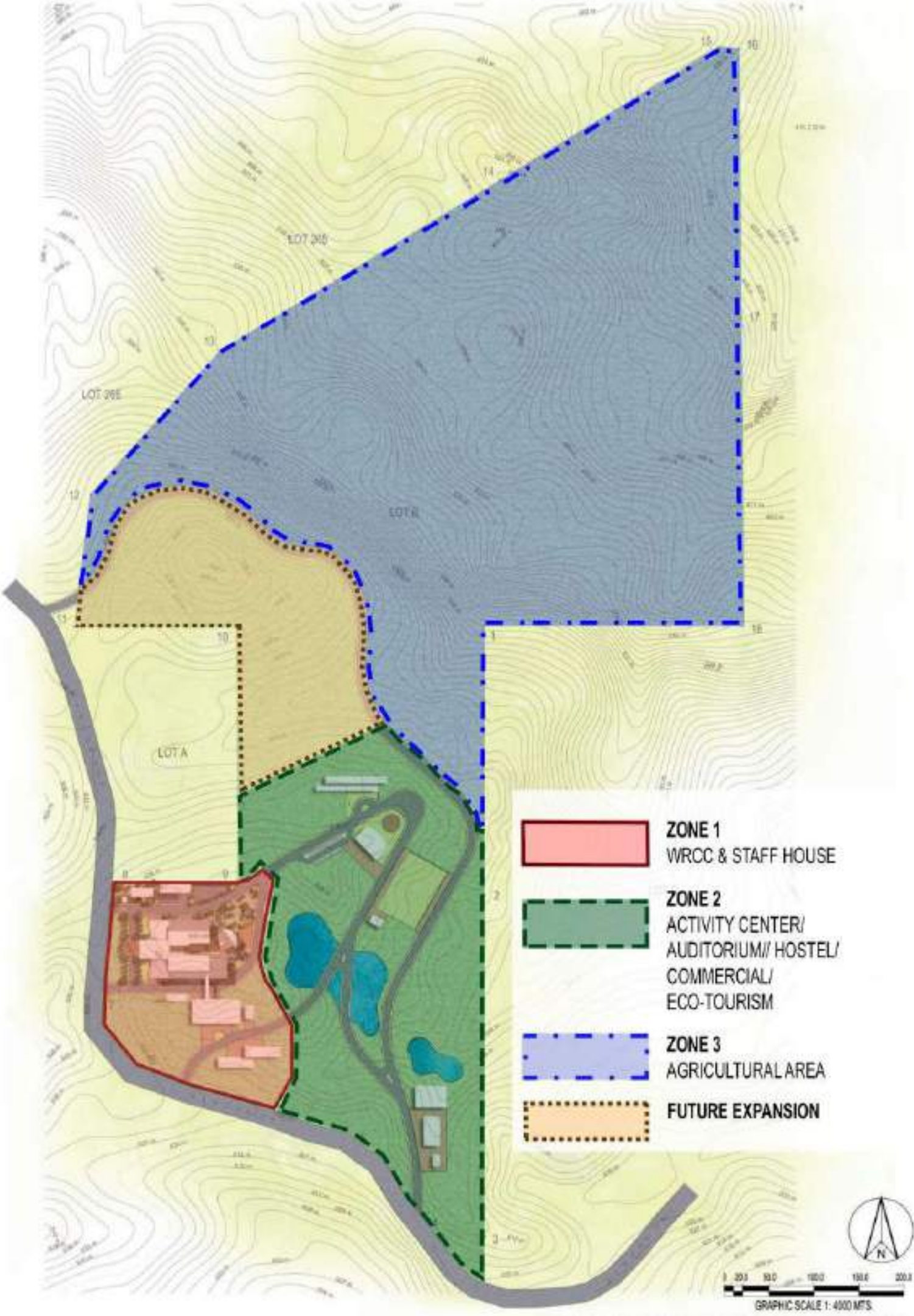


MASTER DEVELOPMENT PLAN

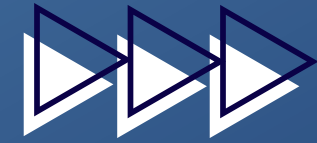
