WeCare Arts Experiences

Section 1: Overview

What is the WeCare Arts Experiences scheme?

WeCare Arts Experiences is a collaboration between the National Arts Council (NAC), the People's Association (PA) and the five Community Development Councils (CDCs). It encourages beneficiaries of Social Service Agencies (SSAs) and community partners, such as Grassroots Organisations (GROs) and Self-Help Groups (SHGs), to access arts and cultural experiences by Singapore's cultural institutions, national arts companies, programmes listed under the SG Culture Pass, and signature programmes (e.g. ArtsEverywhere@CDC).

Through these experiences, beneficiaries can bond over a shared arts experience with immediate family members, caregivers or befrienders and strengthen social ties.

What does the scheme support?

WeCare Arts Experiences provides funding support for tickets, transportation, and light refreshments to facilitate the attendance at arts experiences of:

- beneficiaries who are the recipients of an SSA's services and assistance;
- beneficiaries who receive financial and/or social assistance support from CDCs, GROs and SHGs;
- immediate family and caregivers of beneficiaries; and
- volunteers who accompany beneficiaries to the arts experiences.

What is the level of funding support available under this scheme?

The scheme provides funding for the following expenses:

- tickets and/or toolkits of **up to \$60** per person
- transportation:
 - of **up to \$400** per group per programme (at a specific date, time and location, based on estimated capacity of 40 participants per vehicle). Where participant numbers are larger than 40 per programme, organisers may arrange for additional transport provisions which can be funded according to the funding cap.
 - of **up to \$160** per pax per programme for wheelchair-accessible van, if required
- light refreshments of **up to \$12** per person
- excursion insurance for the duration of the excursion day **up to \$500** per programme (if necessary)

Note:

- *All funding caps are inclusive of GST and applicable booking fees.*
- *For any exceptions to the above (e.g purchase of wheelchair accessible seating from a higher ticket tier, providing more costly wheelchair-accessible transportation, etc.), please contact the relevant CDC officer(s) for approval before the commencement of the programme.*
- *All eligible programmes, including non-ticketed (free) programmes, remain eligible for funding under transportation, refreshments, and excursion insurance categories as set out in the funding caps above.*

Section 2: Eligibility

Who can apply for WeCare Arts Experiences?

The scheme is open to the following organisations who wish to facilitate an arts experience for their beneficiaries who receive their services and assistance:

- **Social Services Agencies (SSAs)** that are registered non-profit organisations and members of the National Council of Social Service (NCSS).
- **Self-Help Groups (SHGs)**
- **Community Development Councils (CDCs)** and **Grassroots Organisations (GROs)** under the People's Association (PA) network.

Section 3: Application Process

How do you apply for the scheme?

For **SSAs/GROs/SHGs**: Please email your application (refer to **Annex A**) to the relevant Community Development Council (CDCs) for your district¹, **at least 1 month** before the commencement of the event/programme.

What happens after you submit an application?

All applications will be processed by the CDCs. You may be contacted if further information is required. All proposals submitted to the CDCs will be treated in the strictest confidence.

If your application is successful, the CDC will notify you via email within 14 working days of the application, to confirm the approved budget covering:

- Number of tickets and/or toolkits for the event/programme, if applicable
- Refreshments, transport and insurance arrangements, if applicable
- Contact person(s)

You will then pay for the ticket order and make the necessary arrangements for your beneficiaries. The CDCs will reimburse you upon submission of Evaluation Report (refer to **Annex B**) and other necessary documentations.

Unsuccessful applicants will be notified within the same period.
