NEW APPOINTMENTS TO THE BUILDING AND CONSTRUCTION AUTHORITY (BCA) BOARD

Singapore, 31 March 2021 – BCA Board Members Mr Lim Sim Seng (林森成), Group Head, Consumer Banking & Wealth Management, DBS Bank Ltd, and Er. They provided guidance to BCA on policies and initiatives to drive the transformation of the built environment sector, including the development of the Construction Industry Transformation Map in 2017 and the introduction of the Super Low Energy (SLE) Building programme in 2018 that pushed the envelope of environmental sustainability in Singapore. Their tenure also saw major reviews to enhance safety standards in the built environment sector, among which was the tightening of the lift maintenance regime, as well as the introduction of new escalator safety regulations.
