

**SPECIFIC REGISTRATION REQUIREMENTS FOR SUPPLIERS' REGISTRY**

Supply Head	Title	Description
SY01A	Essential Construction Materials under Part VIA of BCA Act	Supply of essential construction materials under Part VIA of BCA Act and its subsidiary legislation such as sand and granite aggregates.  <b>All applicants are required to have Importer's Licence for essential construction materials issued by BCA.</b>
SY01B	Ready-Mixed Concrete	Supply of ready-mixed concrete.  <b>All applicants are required to have Certificate of Conformity for Ready-Mixed Concrete recognised by the Singapore Accreditation Council (SAC).</b>
SY01C	Other Basic Construction Materials	Supply of other construction materials such as bricks, cement, timber, reinforcement bars and non-structural precast products such as kerbs, drains, etc.  <b>All applicants are required to have agency rights.</b>
SY02	Chemicals	Supply of all forms of chemicals including pollution dispersal chemicals, hardening compounds, adhesives solvents and paints.
SY04	Electrical Equipment	Supply of heavy electrical equipment such as switchgears and transformers. Firms must have facilities and personnel to provide maintenance and back-up services for the equipment supplied.
SY05	Electrical & Electronic Materials, Products & Components	Supply of electrical and electronic products and materials such as batteries, electrical cables and wires, lightings, and includes control and measuring instruments.
SY06	Finishing & Building Products	Supply of all finishing & building products such as carpets, tiles, ceiling boards, awnings, blinds, wallpapers, non-structural precast products.
SY07	Gases	Supply of gases including oxygen, nitrogen, hydrogen, nitrous oxide, chlorine, carbon dioxide and oxyacetylene gases.
SY08	Mechanical Equipment, Plant & Machinery	Supply of mechanical plants and equipment including generators, air compressors, pumps, lathes, boilers, bulldozers, cement mixers, cranes, gondola systems, turbines and earthwork vehicles. Weapons are excluded. Firms should possess facilities and personnel to provide maintenance and back-up services. Supply of commercial and passenger vehicles should register with MOF's Government Supplier Registration.
SY09	Mechanical Materials Products & Components	Supply of mechanical materials, products and components including ferrous and non-ferrous castings, machine tools, rollers, conveyor belts, valves, and spare parts for mechanical equipment.
SY10	Metal and Timber Structures	Supply of aluminium, steel, steel alloy and timber structural components, metal scaffolds.
SY11	Petroleum Products	Supply of all petroleum products and by-products including lubricants, bunker oil, diesel, gasoline and greases. Equivalent synthetic product suppliers can also be considered for registration.
SY12	Pipes	Supply of all forms of pipes made of steel, concrete, PVC, or their combination.
SY14	Sanitary Products	Supply of sanitary fittings including washing basins, bidets, toilet bowls and bathtubs. Supplier of pipes should be registered under SY12.

**SPECIAL CONCESSIONARY RULES**

Except for SY01A, SY01B and SY01C, where a particular firm has insufficient track record but has the agency rights for the supply of certain products, BCA may permit the firm's entry to the financial grade applied if their paid-up capital and net worth meet the requirements in Table B2.

**Notes for Table B1 and B2**

1. Both minimum paid-up capital and minimum net worth must meet the financial requirements.
  - a. Grades L5 and L6 firms are required to submit the latest audited accounts (not more than 12 months old). For applicant that submit consolidated accounts, the applicant's paid-up capital and net worth, and not the Group's, shall be considered when assessing if the applicant meets the financial requirements. If there is any qualified, adverse, or disclaimer opinion issued by the auditor in the audited accounts, BCA may register the applicant at a different grade from what was applied for.
  - b. Grades L1 to L4 firms may submit the latest management accounts (not more than 12 months old) instead.
2. For SY01A, SY01B and SY01C, no track record is required for all grades.
3. Personnel requirements only apply to SY04 and SY08 registrations only. The types of personnel are defined as follows:
  - a. P – Professional. P refers to personnel with a degree in Mechanical, Electrical/Electronics Engineering, or equivalent approved by BCA.
  - b. T – Technician. T refers to personnel with a diploma in Mechanical, Electrical/Electronics Engineering, or equivalent, awarded by BCA Academy, Nanyang Polytechnic, Ngee Ann Polytechnic, Republic Polytechnic, Singapore Polytechnic or Temasek Polytechnic.
    - i. A holder of BCA Builder Certificate or National Trade Certificate II (NTC 2) in mechanical/electrical trade can be considered for L1 to L3.
    - ii. BCA may also approve such other diplomas or qualifications from time to time.
