EXPLANATORY NOTES

- (1) This form is to be filled up by:
- (i) applicant for the permit or the holder of the permit (Section A);
 - (ii) qualified person vacating the appointment (Section B); and
 - (iii) substitute qualified person replacing the qualified person vacating the appointment (Section C).

Each party may fill up the form separately and submit it to the Commissioner separately.

- (2) Section A and B of this form shall be filled up, and submitted within 14 days after the qualified person's vacating of the appointment, in order to notify the Commissioner of the vacating of the appointment. If the substitute qualified person has not been appointed within the 14 day period, **Section A paragraph 4** can be left blank until the substitute qualified person has been appointed (refer to explanatory note (3)).
- (3) The applicant for the permit or the permit holder shall appoint another qualified person (substitute qualified person) within such time as may be allowed by the Commissioner and notify the Commissioner within 7 days of the substitute appointment by filling up and submitting Section A (**including paragraph 4**) of this form. If the applicant for the permit or the permit holder has previously submitted the notification mentioned in explanatory note (2) without filling in Section A paragraph 4, he would need to re-fill in Section A (including paragraph 4) and re-submit this form again.
- (4) Submission is to be done via the BCA feedback form (<https://www2.bca.gov.sg/feedback/>).
- (5) If the qualified person vacates his appointment before issue of installation permit or modification permit, the substitute qualified person shall review the design and specifications and the proposed installation / modification method and programme of the amusement ride to be installed / modified, and issue a certificate of conformance of design or certificate of conformance of modification. The substitute qualified person shall fill up and submit the Application for An Amusement Ride Installation / Modification Permit form after his review is completed and certificate is issued.
- (6) If the qualified person vacates appointment during installation or modification works, the holder of installation / modification permit shall ensure that the installation / modification works are ceased until all of the following have been done:-
- (i) the Commissioner is notified of the vacating of appointment,
 - (ii) the substitute qualified person is appointed, and
 - (iii) the Commissioner is notified of the substitute appointment.
- (7) There are no fees associated with the notification of change of qualified person of amusement ride.
