Circular Applicable to Registered Training Providers

1. This is a Circular Applicable to Registered Training Providers issued for the purposes of the *SkillsFuture Singapore Agency Terms for Training Providers* (“**Terms**”) (“**Current Circular**”).
2. For the purposes herein, all documents published on www.tpgateway.gov.sg in the “*Announcements and Circulars*” section as on 1 October 2025 with the exception of the following documents:-

3. Further, for the purposes herein, :-
 - (a) documents identical to the Subject Documents published by the SkillsFuture Singapore Agency through whatever medium and in whatever form or manner shall hereinafter be referred to as “**Identical Documents**”; and
 - (b) any document amounting to a “Circular” as defined in and issued pursuant to any version of the Terms preceding the 2 October 2025 version, not amounting to a Subject Document, an Identical Document or any of the documents mentioned in the table in paragraph 2 above, shall hereinafter be referred to as “**Other Circular**”.
4. Without prejudice to the operation of paragraph 2 above, Subject Documents include all documents published on www.tpgateway.gov.sg in the “*Announcements and Circulars*” section as on 1 October 2025 :-
 - (i) with titles containing the term “*Information Memorandum*”;
 - (ii) which are labelled “*Information Memorandum*”; or
 - (iii) which are labelled “*Circular (For Information)*”.
5. With immediate effect:-

- (a) None of the Subject Documents, Identical Documents and Other Circulars shall amount to a Circular for the purposes of the Terms or be legally binding.
 - (b) All of the Subject Documents, Identical Documents and Other Circulars (insofar as they have legal effect) shall cease to have legal effect.
 - (c) Notwithstanding anything set out in any of the Subject Documents, Identical Documents or Other Circulars, nothing in any of the Subject Documents, Identical Documents or Other Circulars shall:-
 - (i) be construed as any binding representation, undertaking or promise on the part of SSG;
 - (ii) operate to impose any obligation whatsoever on SSG or bind SSG to any position; or
 - (iii) operate as a waiver of any of SSG's rights, or operate to diminish or detract from SSG's rights.
