Description of the Online Harm	
Describe the online harm which occurred, by answering questions 1 to 4 below.	I am Jane Ng's counsellor. A colleague of Ms Ng informed her that she is being attacked online, and showed her a screenshot of a chat group named "SG Whispers" on the messaging application Platform ABD. In the screenshot, there was a post by a user named "BadUser" which contained Ms Ng's full name, a photograph of her face and her handphone number. The post added "Jane Ng is a slut who will steal your man. This is the number she uses to text your boyfriend. All of you should let her know what you think." The message was time-stamped 30 June 2026 10.02am. Ms Ng did not consent to any such disclosure of her handphone number and does not know who

	is “BadUser”. Ms Ng is also not a member of the chat group, which is by-invite only. Ms Ng does not have the URL to the group. We do not know if Ms Ng’s details are still up, how many users in the group can access it and who runs the group. Ms Ng does not have an account on Platform ABD.
Any other relevant information? (optional)	Ms Ng’s colleague has informed that she cannot see a phone number tagged to “BadUser”. Ms Ng had flagged the content on 30 June 2026 at 10.30am.
