Dear Parents and Guardians,

JOINT ADVISORY NOTICE FROM FAIRFIELD METHODIST SCHOOL (SECONDARY) AND LAND TRANSPORT AUTHORITY

The Land Transport Authority (LTA) and our school have received feedback from the local community, on vehicles parking/waiting indiscriminately along Dover Road and North Buona Vista Road before/after school dismissal hours.

We would like to remind parents and guardians of the parking and waiting regulations along the mentioned roads. LTA will not hesitate to take enforcement actions against any vehicles that wait or park illegally. We are working closely with the school to ensure the safety of the children and other road users.

While we understand the need for parents and guardians to pick up their children, such inconsiderate waiting and parking causes inconveniences, obstruction to traffic and safety issues. Vehicles that wait and park indiscriminately have been observed to be severely affecting other road users as well as school children along these roads. This has also caused a service disruptions to buses operating along Dover Road and North Buona Vista Road.

These inconsiderate and dangerous acts have posed safety concerns to all road users. The authorities **will not hesitate to take enforcement actions** against errant road users who flout traffic rules and regulations. Offenders are liable to face the following penalties:

a	Parking a vehicle on a road with an unbroken double yellow line	\$70	\$110	-
b	Parking at any entrances or exits of any other premises	\$70	\$110	-
c	Parking a vehicle within 3m of a fire hydrant, 6m of a road or street junction, or 9m of a bus stop	\$70	\$110	-
d	Stopping a vehicle in a manner which causes unnecessary obstruction to other road users	\$70	\$110	-
e	Parking abreast to another vehicle	\$120	\$180	3
f	Stopping in a zebra-controlled area (demarcated with single white zig-zag line and inclusive of zebra-crossing area)	\$120	\$180	3

To prevent further traffic congestion and crowding outside the school gates, vehicles that wait or park illegally along Dover Road and North Buona Vista Road (see Annex A) before 1.30pm on school days **will be subject to enforcement actions**. Vehicles that arrive early and park indiscriminately will cause inconvenience, obstruction, and danger to other road users.

Members of the public (including parents and members of the school community) are encouraged to take photographs of the offending vehicle and submit to LTA for processing of such violations. LTA will also continue to deploy wardens, and errant motorists may **be subject to enforcement actions**.

We thank you for your understanding and cooperation on the above. Please plan your arrival time accordingly and we seek the cooperation of parents and guardians to arrive only when they are ready to pick up their child immediately. Together, let us play our part in making the roads safe for all, especially our children.
