From us at IPOS to you — best wishes for a Fulfilling New Year, and welcome to our latest updates on developments relating to IP & tech dispute resolution in Singapore.

### **Successful Private Prosecution at Singapore State Court**

According to a [news report by CNA](#), the Composers and Authors Society of Singapore (COMPASS) successfully mounted an uncommon private prosecution against Slim Entertainment, the owner of a karaoke lounge. It was found to have caused the musical and literary works in songs, including songs by well known Asian singers Jay Chou and JJ Lin, to be performed in public for its private profit. Despite multiple approaches by COMPASS, Slim Entertainment refused to obtain licences. Slim Entertainment was fined S\$20,000 (US\$16,000). A separate private prosecution against Slim Entertainment's director is still pending.

### **IPOS decision**

[Cosmetic Warriors Limited v Genpulse Pte Ltd](#) [2026] SGIPOS 1



The Principal Assistant Registrar found that the Application Mark “” and the Opponent’s “LUSH” trade mark were not similar, even if both marks claimed beauty care and skin care services in Class 44. They were distinguishable as wholes visually, aurally and conceptually. Even if the marks were found similar, the nature of the services were such that the consumer would be unlikely to be confused under the usual circumstances of selection and purchase, as an above average degree of attention would be paid thereto. Consequently, the opposition failed on various grounds with the requisite element of confusing similarity and misrepresentation.

## **Renewal of WIPO-ASEAN Mediation Programme (AMP+) in 2026**

ASEAN enterprises and individuals with IP/technology disputes, or with outstanding terms to be agreed in IP/technology deals under negotiation, can benefit from funding for mediation to reach win-win outcomes. Read some real-life cases [here](#).

The [WIPO-ASEAN Mediation Programme](#) (AMP+) is an initiative between the WIPO Singapore Office and ASEAN. We are happy to announce that AMP+ has been renewed and is available until **31 December 2026** or until the AMP+ fund is drawn down, whichever is earlier. View the [information sheet and frequently asked questions](#).

The WIPO Arbitration and Mediation Center will provide [mediation services](#) under AMP+. Each mediation case involving at least one ASEAN party may be funded up to SGD 5000. The [Intellectual Property Office of Singapore](#) (IPOS) adds its support where parties appoint a Singapore-based mediator. Parties will receive up to a maximum of an additional SGD 2000 (making total funding at a maximum of **SGD 7000**).

ASEAN parties with IP/technology disputes or negotiations are welcome to apply for WIPO mediation and AMP+ funding.

A Malaysian company specialising in manufacturing and distribution of spice powders and a Singapore wholesale trading company successfully resolved their dispute well within a working day. This case is testament to the benefits of mediation's efficiency and focus on commercial objectives rather than legal technicalities, enabling the preservation of business relationships.

### **Media coverage on pioneer lawyer in cryptocurrency disputes appointed senior counsel**

At the Opening of the Legal Year on 12 January 2026, the Chief Justice announced the appointment of Singapore lawyer Danny Ong Tun Wei as Senior Counsel, in recognition of excellence in advocacy and legal knowledge. Ong led the first successful cryptocurrency claim in 2019 before the Singapore International Commercial Court, as reported by [The Business Times](#) and [The Straits Times](#). The landmark decision was upheld by the Singapore Court of Appeal in [Quoine Pte Ltd v B2C2](#) [2020] SGCA(I) 02.
