Licensees of Clinical Laboratory Service and Assisted Reproduction Service providing or intending to provide Pre-implantation Genetic Testing for Monogenic or Single Gene Defects or Chromosomal Structural Rearrangements (PGT-M/SR)

WRITTEN DIRECTION ON MODIFICATIONS TO LICENCE CONDITIONS UNDER SECTION 14(4) OF THE HEALTHCARE SERVICES ACT 2020 (“HCSA”)

Following the issuance of the MOH Circular No. 05/2024 titled “Notice of Proposed Modifications to Licence Conditions for Clinical Laboratory Service and Assisted Reproduction Service Licensees Providing or Intending to Provide PGT-M/SR under section 14(2) of the Healthcare Services Act 2020” dated 11 February 2025, the Director-General of Health requires you to give effect to the modification as specified in paragraph 2.

2 The modification is the addition of the following conditions to the list of allowable conditions for which PGT-M/SR can be performed (at Annex A of your license):

- i. PGT-M for *AGT*-related renal tubular dysgenesis
- ii. PGT-M for Developmental and Epileptic Encephalopathy 44 (DEE 44), *UBA5* gene
- iii. PGT-M for *INS*-related permanent neonatal diabetes mellitus
- iv. PGT-M for Maple Syrup Urine Disease (MSUD)
- v. PGT-M for Lynch syndrome 2 (MLH1)
- vi. PGT-M for *PALB2*-associated Cancer Predisposition Syndrome (*PALB2*)
- vii. PGT-M for *STAT3* Hyper IgE Syndrome (*STAT3*-HIES)
- viii. PGT-M for X-linked hypophosphatemia (XLH)
- ix. PGT-M to exclude embryos with 2 pathogenic *Plakophilin-2* (*PKP2*) gene variants
- x. PGT-SR for inv(8)(p11.2q22.1)

- xi. PGT-SR for t(1;3)(p34;p21)
- xii. PGT-SR for t(3;15)(p10;p10)
- xiii. PGT-SR for t(4;9)(p16.3;p13)
- xiv. PGT-SR for t(4;16)(p15.3;p13.3)
- xv. PGT-SR for t(5;7)(p12;q31.3)
- xvi. PGT-SR for t(5;8)(q23.3;q23)
- xvii. PGT-SR for t(7;15)(q21.2;q25)
- xviii. PGT-SR for t(Y;9)(q12;q21.12)
- xix. PGT-SR for dup(X)(q13.1q21.1)
- xx. PGT-SR for del(X)(q21.2q26)

3 The Director-General of Health requires you to give effect to this modification immediately. All other conditions of your license that have been imposed before the date of this written direction remain unchanged. The revised licence conditions are found in **Appendices I and II**, as applicable to you.
