Licensees of Acute Hospital Service and Community Hospital Service (“**Licensees**”)

**NOTICE OF MODIFICATION OF LICENCE CONDITIONS UNDER THE HEALTHCARE SERVICES ACT 2020 (“HCSA”): LICENCE CONDITIONS FOR ACUTE HOSPITAL SERVICE LICENSEES AND LICENCE CONDITIONS FOR COMMUNITY HOSPITAL SERVICE LICENSEES**

Following the issuance of the MOH Circular 09/2025 (“**MOH Circular**”) titled “Notice Of Modification Of Licence Conditions Under The Healthcare Services Act 2020 (“**HCSA**”)” dated 7 March 2025, the Director-General of Health received written representations in respect of the matters set out in the MOH Circular.

2. Having carefully considered the written representations received, the Director-General of Health has further amended the proposed licence conditions annexed to the MOH Circular, to provide further clarity on the EatSafe Singapore standards; and to ensure the safe and effective provision of dietetic and nutrition services provided by Licensees as part of the acute hospital service (“**AHS**”) and community hospital service (“**CHS**”).

3. The Director-General of Health hereby directs that you give effect to the modifications to the conditions of your licence (“**Licence**”) granted under the HCSA, as set out below by **26 Aug 2025**: -

(a) Licensees of AHS are to give effect to the licence conditions for AHS Licensees at **Annex A** (with amendments marked-up); and

(b) Licensees of CHS are to give effect to the licence conditions for CHS Licensees at **Annex B** (with amendments marked-up),

(collectively, “**LCs**”).

4. The LCs, when implemented, shall be read and construed with the requirements stipulated in the HCSA and its Regulations. All other licence conditions applicable to you shall remain unchanged and in full force and effect (unless superseded by the LCs).

5. A breach of the LCs, when implemented, may result in regulatory action being taken against you under section 20 of the HCSA, including but not limited to —


- (a) suspension or revocation of the Licence;
- (b) shortening the term of the Licence;
- (c) a direction requiring you to rectify the contravention, or prevent a recurrence of the contravention; and/or
- (d) a direction requiring you to pay a financial penalty.
