Licensees of Clinical Laboratory Service and Assisted Reproduction Service providing or intending to provide Pre-implantation Genetic Testing for Monogenic or Single Gene Defects or Chromosomal Structural Rearrangements (PGT-M/SR)

**NOTICE OF PROPOSED MODIFICATION TO LICENCE CONDITIONS FOR CLINICAL LABORATORY SERVICE AND ASSISTED REPRODUCTION SERVICE LICENSEES PROVIDING OR INTENDING TO PROVIDE PGT-M/SR UNDER SECTION 14(2) OF THE HEALTHCARE SERVICES ACT 2020 (“HCSA”)**

The Director-General of Health proposes to modify the conditions of your licence granted under the HCSA by adding the following conditions to the list of allowable conditions for which PGT-M/SR can be performed (at Annex A of your license):

Conditions to be added

- I. PGT-M for Leber Congenital Amaurosis 9 (LCA9)
- II. PGT-M for *MANBA*-related Mannosidosis beta
- III. PGT-M for Osteogenesis Imperfecta, type I, *COL1A1*
- IV. PGT-M for Pontocerebellar hypoplasia type 7 (PCH7)
- V. PGT-M for Breast-ovarian cancer, familial, susceptibility to, 4, *RAD51D*
- VI. PGT-M for Bardet Biedl syndrome, *BBS2*-related
- VII. PGT-SR for t(1;8)(q43;q22.3)
- VIII. PGT-SR for t(2;12)(q13;q15)
- IX. PGT-SR t(3;17)(q21;p13)
- X. PGT-SR for t(4;8)(q22;p23.2)
- XI. PGT-SR for t(7;19)(p22;p13.1)
- XII. PGT-SR for t(8;12)(q23;q13.2)
- XIII. PGT-SR for der(14;15)(q10;q10)
