Licensees of Acute Hospital Service, Ambulatory Surgical Centre Service and Outpatient Medical Service (“**Licensees**”)

LICENCE CONDITIONS FOR ACUTE HOSPITAL SERVICE, AMBULATORY SURGICAL CENTRE SERVICE LICENSEES IMPOSED UNDER THE HEALTHCARE SERVICES ACT 2020 (“HCSA”)

Following the issuance of the MOH Circular 40/2025 titled “Notice of Proposed Modifications to Licence Conditions for Acute Hospital Service, Ambulatory Surgical Centre Service Licensees Imposed Under the Healthcare Services Act 2020 (“HCSA”)” dated 10 July 2025, the Director-General of Health shall modify the conditions of your licence granted under the HCSA (“**Licence**”) by imposing the following appended conditions for your Licence (“**Licence Conditions**”). Please refer to **Annex A** for the Licence Conditions applicable to the acute hospital service, ambulatory surgical centre service and/or outpatient medical service (“**Service**”) you are providing. These Licence Conditions will take effect from the date of issuance.

2 As clarified in MOH Circular 40/2025, the modifications to the Licence Conditions are intended to update the training requirements for Radiation Oncologists and Clinically Qualified Medical Physicists who are, or intending to be, employed or engaged as part of a proton beam therapy (PBT) service.

3 The Licence Conditions will apply to all persons which have been licensed under the HCSA to provide a Service, and are intended to provide further clarity on the requirements to ensure the safe and effective provision of a Service, including any specified services provided as part of the Service. All other conditions of your Licence that have been imposed before the date of this notification shall remain unchanged and in full force and effect (unless superseded), and these Licence Conditions shall be read and construed with the requirements stipulated in the HCSA and its

Regulations [including but not limited to the Healthcare Services (General) Regulations 2021, the Healthcare Services (Advertisement) Regulations 2021] and the relevant Service Regulation(s).

4 A breach of the Licence Conditions may result in regulatory actions being taken against licensees under section 20 of the HCSA, including but not limited to —

- (a) suspension or revocation of the licensee's Licence;
- (b) shortening the term of the licensee's Licence;
- (c) a direction requiring the licensee to rectify the contravention, or prevent a recurrence of the contravention; and/or
- (d) a direction requiring the licensee to pay a financial penalty.
