

# Two-stage registration for the 31 Oct – 1 Nov 2026 RES examination

## Stage 1: Indication of Interest (17 Sep 2026, 9 am to 12 noon)

- To be eligible to indicate interest, applicants must possess a valid Certificate of RES Course Completion or have completed their RES course **by 16 Sep 2026**.

- Applicants are required to log in GovEntry with their Singpass.** Applicants are advised to access the form using personal devices with the latest version of the internet browser. Do not use employer-issued devices with security features installed as there may be access issues after Singpass authentication.
- After Singpass authentication, applicants will be admitted into the form directly.**
- Information required: full name as per NRIC/FIN, contact number, and email address.
- Select either Full or Modular sitting\* *Modular sitting applies to an applicant who is exempted from Paper 1 of the RES examination OR has a valid pass for one of the papers.*
- Only one submission per NRIC/FIN is allowed.**
- Applicants will be disqualified if they choose the wrong examination type.**
- Applicants who meet the eligibility criteria will be shortlisted on a **first-come, first-served basis based on the timestamp of their form submission.**
- Please note that a submission of interest does not mean a confirmation of an examination seat.

## Two-stage registration for the 31 Oct – 1 Nov 2026 RES examination

### Stage 2: Examination Registration & Payment (1 to 4 Oct 2026)

- NTUC LearningHub will **contact shortlisted applicants via email by 30 Sep 2026** to provide instructions on completing the examination registration on NTUC LearningHub's website from 1 to 4 Oct 2026.
- Shortlisted applicants are required to upload supporting documents and make payment online to complete the examination registration.
- Applicants will see the following message upon successful completion of the exam registration and payment.

- Shortlisted applicants who do not complete the examination registration by NTUC LearningHub's Stage 2 deadline will have their seats released to those on the waitlist. **Applicants on the waitlist will hear from NTUC LearningHub by 8 Oct 2026** whether there are seats available, or they are unsuccessful.
