## Form S16(2) – Assumption of Liability Notice

### **EXPLANATORY NOTES**

1. “assume liability” has the meaning given by Section 16 of the Land Betterment Charge Act.
2. “Default taxable person” has the meaning given by Section 16(2)(b) of the Land Betterment Charge Act.
3. “Chargeable Consent” has the meaning given by Section 3 of the Land Betterment Charge Act.
4. Any notice submitted to the Singapore Land Authority after a revised liability order is given with respect to the same Chargeable Consent will be not be considered.
5. A person is deemed to have assumed liability on the day on which Singapore Land Authority receives and acknowledges receipt of a valid assumption of liability notice from that person.
6. A person who assumes liability in accordance with Section 16 of the Land Betterment Charge Act is liable to pay an amount of the land betterment charge equal to the amount that the default taxable person(s) would have been liable to pay if not for this assumption of liability; and the default taxable person(s) then ceases to be liable to pay that amount of the Land Betterment Charge.
7. An assumption of liability notice given in accordance with Section 16 of the Land Betterment Charge Act is irrevocable.
8. Please note that incomplete notices will be treated as null and void.
