#### PRACTICE CIRCULAR 1 OF 2024

To All Law Firms / Law Organisations

#### (A) Electronic lodgment of more instruments without paper lodgment

- 1. As part of our ongoing effort to move progressively towards a fully electronic environment, I am pleased to announce that effective 1 February 2024, the Land Titles Registry (Registry) will dispense with the requirement to lodge the hard copies of the following instruments after they have been lodged electronically:
  - a) Partial Discharge of Charge
  - b) Total Discharge of Charge
  - c) Application to Notify Statutory Obligation
  - d) Transfer of Mortgage
  - e) Transfer of Charge
  - f) Management Corporation Charge
  - g) Application for Certificate of Title for a Private Leasehold Estate Comprised in a Lease
  - h) Application for Subsidiary Certificate of Title for a Private Leasehold Estate Comprised in a Lease
  - i) Application for Replacement of Certificate of Title

The forms for the above 9 instruments are available at https://app.sla.gov.sg/starsELS/jsp/common/index.jsp.

- 2. The electronic instruments must be signed digitally by the solicitors on behalf of the parties to the instruments. The certified true copy of documentary evidence and other annexures like original Statutory Declarations are required to be uploaded as an attachment to the instrument lodged.
- 3. Lodgment of the hard copies of the above instruments executed prior to 1 February 2024 will continue to be accepted by the Registry. For such instruments, solicitors are required to state clearly in ink the date of execution e.g. "Executed on DD/MM/YYYY" or "Executed prior to 1 February 2024".

#### (B) Land Titles (Amendment) Rules 2024

4. Notwithstanding the Land Titles (Amendment) Rules 2024, the Registry will continue to accept for lodgment forms that are already paperless, including those that have been removed from Rule 15A of the Land Titles Rules. This is because digital instruments that do not purport to dispose of or create an interest in land and which must be electronically or digitally signed are already provided for under the Land Titles (Electronic Lodgment) Rules.

- 5. The new Rule 18A provides for the lodgment of forms by parties who are not represented by a solicitor. As there is no solicitor acting for such parties, the hard copies of the above instruments may be signed and lodged manually.
- 6. Please see Annex A for the list of digital and non-digital forms with effect from 1 February 2024.

#### (C) Uploading of Supporting Document(s)

7. With effect from 1 May 2024, the Registry will no longer accept hard copy documentary evidence or annexure(s) for instruments that are no longer required to be lodged in hard copy. Instead, they should be uploaded to the digital instrument for lodgment using the function in ELS at "eLodgment" — "Instrument/Form" — "Link/ Delink Supporting Document".
