2. To obtain the Singapore Land Authority's approval, the transferor must identify the person ("transferee") to whom the deferred liability to pay the Land Betterment Charge is being transferred, accompanied by the consent of the transferee(s) to assume the deferred liability.
3. The relevant deferment determination must be attached to this notice.

EXPLANATORY NOTES

1. "Deferment Determination" has the meaning given by Section 20 of the Land Betterment Charge Act.
2. "Transferor" and "Transferee" have the meaning given by Section 23(1) of the Land Betterment Charge Act.
3. The transferee is deemed to have assumed the transferor's deferred liability to pay a Land Betterment Charge on the day on which Singapore Land Authority approves the transferor's application, in accordance with Section 23(1) of the Land Betterment Charge Act.
4. Upon approval of the transfer of deferred liability, Singapore Land Authority will issue a copy of the approval to the transferee, accompanied by the relevant deferment determination setting out the details of the deferred liability transferred.
5. Please note that incomplete notices will be treated as null and void.
