CHANGES TO THE SMC REGISTRATION PROCESS FOR CONDITIONALLY AND PROVISIONALLY REGISTERED DOCTORS

- 1 The Singapore Medical Council (SMC) has recently reviewed the registration process for Conditional Registration (C-reg) and Provisional Registration (P-reg).
- 2 Unless otherwise indicated, the changes will take effect from 1 January 2023.

DOCTORS UNDER CONDITIONAL REGISTRATION

(A) Current C-reg Doctors

- Unless they do not comply with Section 21(6) of the Medical Registration Act (MRA)¹, SMC will no longer cancel the registration for C-reg doctors if they:
 - a) resign or cease employment; or
 - b) change their employer and approved place of practice.

¹ Section 21(6) of the MRA:- The Medical Council may cancel the conditional registration of a medical practitioner if -

a) the medical practitioner fails to comply with any of the conditions or restrictions specified in the direction by virtue of which the person is registered; or

b) the Medical Council is of the opinion, having regard to any report of one or more fully registered medical practitioners supervising the person and any reviews of the medical practitioners or healthcare professionals mentioned in subsection (4)(b) (if any) that the person is unable to perform the duties of a medical practitioner satisfactorily.

4 SMC will only suspend the conditions attached to the registration that were stipulated in the initial C-reg approval letter and **cancel the doctor's Practising Certificate**² (PC) if the doctor is no longer under the employment of a SMC-approved healthcare institution.

What if C-reg doctor with Suspended Conditions wishes to resume clinical practice

If the doctor wishes to resume practice in Singapore, the request must be submitted online via SMC's <u>Professional Registration System (PRS)</u>. Once approved, a letter will be issued to him/her with the new conditions and the doctor may proceed to apply for a new PC.

(B) Varying Conditions of Registration for C-reg Doctors

If a doctor or employer wishes to vary the C-reg conditions³, the employer must seek SMC's approval first for the variation of conditions of registration. Upon approval, the new C-reg approval letter will be issued. The doctor may be informed to make payment if a replacement Registration Certificate is required for certain categories of applications.

PROVISIONAL REGISTRATION

- P-reg doctors are given 12 months to complete their Postgraduate Year 1 (PGY1) training to obtain their Certificate of Experience. If the P-reg doctor needs to extend the training, an online application (via <u>PRS</u>) must be submitted to vary the conditions of P-reg for the given duration to complete the training. On approval, a letter will be issued for the doctor to proceed to apply for a new PC.
- For P-reg doctors who resign or cease employment with MOH Holdings Pte Ltd (MOHH), SMC will suspend the conditions⁴ attached to his/her P-reg and cancel his/her PC⁵ as the doctor is no longer under the employment of MOHH. For resumption of PGY1 training, an online application (via PRS) must be submitted. On approval, the doctor may apply for a new PC.

² If they applied for the grant or renewal of PC on or after 1 July 2022.

³ For example: a) change practice place with no change in employer, b) add practice place, or c) change employer with no change in practice place.

⁴ However, the Medical Council may still cancel the provisional registration of a medical practitioner if

a) he fails to comply with any of the conditions or restrictions of his provisional registration; or

b) the Medical Council is of the opinion, having regard to the report of one or more registered medical practitioners supervising him and the reviews (if any) of the registered medical practitioners or healthcare professionals working with him, that he is unfit or otherwise unable to practise medicine.

⁵ If they applied for the grant or renewal of PC on or after 1 July 2022.
