Interest applicants must meet the following criteria:

- Singapore citizen or Singapore Permanent Resident (SPR) for stallholder and stall assistant.
- Able to provide good service, good variety and quality food with reasonable prices determined in consultation with the school.
- Able to provide cooked food that meets the health / nutritional standards set by the Health Promotion Board (HPB) under the “Healthy Meals in Schools Programme (HMSP)” guidelines.
- Able to maintain high standard of food safety and personal hygiene.
- Healthy and fit to operate the stall.
- Must be in personal attendance at the stall during operating hours.
- Prior experience in running a school canteen stall is an added advantage.

Applicants should preferably fulfil the following criteria:

- Successful applicant and stall assistant(s) must possess the WSQ Basic Food Hygiene Certificate.
- Possess catering experience or experience operating in a school environment.
- Successful applicant is required to apply for a food stall license from
- Singapore Food Agency (SFA). They may apply the License from GoBusiness website.

Shortlisted applicants will be notified for an interview and will be required to provide food sampling for the School Canteen Selection Committee at the applicant's own expense.
