

Terms and Conditions

(A) National Day (NDP) 2026 Social Media Giveaways

1. The NDP 2026 Giveaways are organised by the Ministry of Defence (MINDEF) on NDPeep's Instagram, Facebook and Tiktok social pages.
2. The NDP 2026 Social Media Giveaways requires each Participant to complete the items mentioned in the post caption to be eligible for the giveaway contest:
3. **The prize** consists of:
 - a. 2 pairs of tickets to the any of the listed NDP 2026 Shows
 - Preview 1 (25 July)
 - Preview 2 (1 August)
 - Actual Day (9 August)

By entering the Giveaway Contest, the Participant agrees to be bound by these Terms and Conditions, which shall form a valid and binding agreement between the Participant and the Organiser.

(B) Eligibility

1. This Giveaway Contest is open only to **Singaporean/ Permanent Residents** in Singapore.
2. Only one (1) Entry per Participant will be considered, even if multiple entries are submitted.
3. The following individuals are not eligible to participate in the NDP 2026 Social Media Giveaways:
 - a. Employees and immediate families of the Organisers and their advertising, sales, and promotion agencies.
 - b. Winning participants must not be a ballot winner of the NDP 2026 ticket application open to public

(C) NDP 2026 Social Media Giveaways Mechanics and Rules:

1. Participants must follow the rules and conditions mentioned in the Social Media Giveaway's post caption
2. Only eligible entries left by participants would be included in the random draw on the respective Giveaways
3. Any entry that contains material that the Organiser deems offensive is subject to immediate disqualification and deletion. This includes, but is not limited to, the following:
 - a. Vulgarities, redacted or in full; or
 - b. Racist, sexist, and/or other discriminatory content

4. The Organiser's decision on all matters concerning the NDP 2026 Social Media Giveaways is final and binding. The Organisers are not obliged to enter into any correspondence on any matter concerning the NDP 2026 Social Media Giveaways.

(D) Prizes

1. The winners will be notified within five (5) days of the contest closing by direct message on NDPeeps Instagram, Facebook or TikTok regarding the prize collection arrangement. ("Notification"). By participating in this NDP 2026 Social Media Giveaway Contest, the Participant agrees to the Organiser publishing his or her name on the Pages for the purposes of the NDP 2026 Social Media Giveaway Contest and publicity of NDPeeps.
2. In order to claim his or her Prize, each Participant is required to reply to NDPeeps's direct message with the following information for verification purposes within five (5) days from the time of the Notification: **Full name, mobile number and email address.**
3. Any Participant who does not respond with the information as required in the above clause within the stipulated five (5) days from the time of the Notification will forfeit his or her rights to the Prize.
4. The Prize collection process will be shared through email with the winner via direct message from the Organiser. The organiser will be the point of contact for all prize related enquiries and deliverables. The Organiser will not bear costs and/or related expenses for transportation, mailing, or couriering.
5. The Organiser reserves the right to select reserve Participant(s) to replace any Participant(s) subsequently disqualified.
6. The prize is non-refundable and not exchangeable for cash, credit, or any other item.

 - a. The awarding, acceptance, receipt, possession, use or misuse of any of the Prize or parts thereof awarded pursuant to the contest; or
 - b. The participation in the contest, or any Prize-related activities including, without limitation, the breakdown or malfunctioning of any computer system or equipment.
