

Speaker's Agreement

1. I do hereby consent to the use by the Government Technology Agency ("GovTech") of my:

- a) name, likeness, image, video, voice, and any other identifying information in any Recordings. "**Recordings**" means all video recordings, audio recordings, pictures, photos, digital images, statements (written or oral), and any other form of media; and
- b) presentation and all related materials (including but not limited to transcripts of my presentation) (collectively, "**Presentation**"),

(collectively, "**Content**").

2. I consent to GovTech using the Content without payment for [Industry Engagement] ("Event") I grant GovTech the right to use, perform, display, copy, transmit, broadcast and distribute the Content in all forms and media, including edited, modified or composite versions of the Content or any part thereof in any media or format now known or developed in the future, throughout the world in perpetuity. I agree that the Content may appear publicly on GovTech's social media and digital platforms and/or other marketing materials.

2A. Notwithstanding Clause 2 above, GovTech agrees not to circulate the Presentation to any third parties or publish the Presentation publicly on GovTech's social media and digital platforms and/or other marketing materials (collectively, "**Circulate**") if I inform GovTech not to do so [before the date of the Event], such as by selecting the relevant opt-out option when accepting the Speaker's Agreement via Form.sg or its equivalent. For the avoidance of doubt, the aforementioned does not apply to Recordings that capture the Presentation or any part thereof – GovTech shall retain its right to Circulate such Recordings in accordance with Clause 2.

3. I agree that GovTech shall own all rights in and to the Recordings (including any intellectual property rights), subject to any underlying intellectual property rights that you and/or your employer may have in its content. I agree that GovTech may use and edit the Content as it sees fit. In addition, I waive any right to review or approve the Content, including any edits.

4. I waive any and all intellectual property rights, rights of publicity, rights of privacy and any other legal or moral rights that might preclude, restrict or affect GovTech's ownership of and/or right to use the Content.

5. I warrant and represent that:

- a) I fully own all rights in and to the Presentation and that I have the right to disclose all the information in the Presentation;
- b) I have received all necessary permissions and authorisations, from my employer or otherwise, to give the Presentation, provide the information in the Presentation and enable GovTech to exercise its full rights under this agreement. No other permissions or consent are required from my employer or any third party; and
- c) The Presentation does not contain any confidential information of GovTech, my employer or any other third party unless I have obtained the prior written consent of the owner of the confidential information to disclose the said confidential information.

6. I agree that I shall not use any logos, names, identifying slogans, or trademarks owned by GovTech without GovTech's prior written consent.

7. I consent to GovTech collecting, using and processing my personal data for purposes related to the Presentation, and that GovTech may contact me in relation to the Presentation, attribution information and speaking engagement.

8. I understand that all consent given by me in this agreement is perpetual and binding, and that I shall not revoke the said consent.
